## LETTER FROM THE CHAIRMAN

According to the UK Met Office web-site, 1<sup>st</sup> March marks the first day of **meteorological** spring and 20<sup>th</sup> March 2017 marks the first day of **astronomical** spring. By the time this Newsletter reaches you it will be spring by either definition – and St Andrews is especially beautiful at this time. The lengthening days and quality of light make a walk along the Lade Braes especially pleasurable, with swathes of snowdrops, interspersed with aconites, chionodoxa and emerging daffodils. Unfortunately, in some places, the parlous state of the paths makes it risky to avert one's eyes for too long and cyclists often take one by surprise. Whilst protocols are badly needed to assure safe walking and cycling, it is crucial that any measures taken avoid hard features that would destroy the essentially rural character of the Lade Braes.

It is to be hoped that the long-awaited upgrade of the Lade Braes footpaths will be sympathetic to its sylvan setting. Great care will have to be taken to avoid compromising the trees when addressing the uneven surface caused by root-heave and water damage. It is to be hoped too, that measures will be taken to remove the Japanese Knotweed which, if left unchecked, could accidentally be spread - even if it is rare for its seeds to germinate. Walking further out the Lade Braes it is very pleasing to see Boase Wood bursting into life with spring bulbs. We are very grateful that Special Branch has offered once again to take care of general maintenance.

Thankfully the reporter, appointed by Scottish Ministers, dismissed the appeal to build forty dwellings at the New Park Playing Fields (to which the Trust objected), and the semi-rural views from the Lade Braes will continue to be enjoyed by future generations! The reporter further noted that the Council's Greenspace Audit (2010) found that the average amount of greenspace in St Andrews was well below the Fife average – surely an indication that the planning process is not working as it should.

Greenspaces will be impacted further as St Andrews West LLP develops the 88 hectare site to the west of the town with the development of around 1000 new homes, retail facilities, a care home, hotel, university facilities and business park, and of course a replacement for Madras College. The Trust welcomed the public consultations hosted by St Andrews LLP. Our Planning Committee

turned out in force to discuss the many issues and is currently reflecting on these.

It is also pleasing to note that, on 28<sup>th</sup> February, the Council's Executive Committee declared their preferred option for a site on the western approach to St Andrews for the replacement Madras College. It seems the wheel has turned the full circle and it is deeply regrettable that not more notice was taken of the many representations made by the Trust, the courageous campaign by STEPAL, and many others regarding the benefits of co-location, reduced environmental impacts, safer transport and leaving open the possibility to extend the Community Hospital. Unfortunately the planning process has not served the town well. We hope for better when it comes to St Andrews West and other significant developments in the pipeline, such as Craigtoun North and the East Sands area. The redevelopment of the Madras College South Street buildings will be especially critical to the amenity of the conservation area. I believe there is great opportunity here to enhance the amenity with a wonderful public space.

A crucial factor in all of these developments is managing access and mobility and their links to land-use planning. In my former professional life I was involved in managing research projects on urban mobility. This highlighted the vital importance of developing sustainable urban mobility plans and engaging with *all stakeholders* – especially citizens. St Andrews' transport system is rapidly becoming dysfunctional – especially during the summer. Further development will place intolerable pressure on our historic streets which were never designed for today's motorised traffic. A master plan approach is required – embracing better public transport, safe cycling and walking and much improved Park and Ride. We look forward to further consultation and dialogue with the various stakeholders involved in the new developments.

Winter is most definitely not “off season” for the museum. Our new curator, Nicola Moss, ably assisted by Trustees and volunteers, has been extremely busy preparing for the new season, whilst grappling with renewing our accreditation and preparations for upgrading the museum store at Queen's Gardens. She has drawn up ambitious objectives and interesting exhibitions are planned to mark the 80<sup>th</sup> anniversary of the founding of the Trust – starting with the Easter exhibition “Artists of St Andrews”. The volunteer research group exhibition at the end of January was a great start to the year with fascinating insights into topics ranging from the old mills, early industries, photographers and an eminent mineralogist. I also very much welcome the initiative by the small group involving Nicola and Annie Birrell, our administrator, and volunteers to look at developing our capabilities in education and learning – a great way to encourage our youngsters to develop a sense of place and understand their heritage. Things are also progressing well in the garden at the museum, which I will not report in detail now, other than to remark that it is shaping up to be one of the best small gardens in the area which, I am sure, will become a great draw for visitors.

The start of the year is also one of the busiest times for our treasurer Ian Lumsdaine. As always, Ian has done a sterling job in preparing the financial report. Our finances are in surplus, although we continue to rely on generous benefactors and investment income to make up the deficit between recurrent income and normal expenditure. Grants too, are likely to become ever harder to win. I expect this trend will continue, especially if inflation starts to

take root, so do please remember the Trust should you desire to review your giving.

Looking forward, 2017 promises to be an eventful year, with important and challenging developments starting to take shape. Hopefully substantial progress will be made towards delivery of a new school. 2017 is also the 80<sup>th</sup> anniversary of the founding of the Trust. It is also the 20<sup>th</sup> anniversary of Hidden Gardens. I would like to take the opportunity to pay tribute to the founder members, to current and former trustees and the many very loyal and active volunteers who have contributed to our mission to preserve the buildings, character and history of this great Royal Burgh.

## **POLICY AND RESOURCES REPORT**

The Policy and Resource Committee (PRC) meets periodically to assess progress with respect to the Trust's Strategic and Action Plans and consider responses to new situations as they develop. Whilst the Trust's stated mission, objectives and priorities are very largely of a continuing nature, the means to deliver them through a series of planned actions are at various stages of completion. The PRC is in the process of reviewing the Action Plan and updating it where appropriate. Progress in many of these actions is discussed elsewhere in the respective committee reports and therefore will not be discussed in detail here.

A matter of ongoing concern is the difficulty of recruiting Trustees and the implications of this constitutionally. The committee agreed to invite Mrs Helen Rorrison, Head of Community Development, Fife Voluntary Action, for advice and to review procedures and policies. Fortunately we seem to be meeting our obligations and the committee very much appreciated Helen's intervention.

The committee have also considered the Treasurer's financial reports which note an ongoing deficit on normal operations. Specific areas of high costs noted include electricity, internet, and property maintenance and these will be examined with a view to making savings where possible. Advice will be obtained from St Andrews Environmental Network and Historic Scotland regarding energy use and efficiency. One option being considered is to install gas central heating at the museum.

Direct Debit has been considered as a good way to manage subscriptions and retain membership. The treasurer had obtained offers and it is considered unlikely that the benefit would outweigh the high cost.

On the buildings front, significant maintenance work is required on the Bogward doocot but this will be postponed until the Trust has title – the terms of the disposition are understood to have been agreed and formalities are being concluded.

Considering environmental matters, the committee again noted concern about 1 Greyfriars Garden but welcomed the positive report from the convenor of the environment committee concerning BID's "Clean and Green" initiative and trial of a "Big Belly" automatic compacting bin.

Options for marking the 80<sup>th</sup> anniversary of the founding of the Trust in 2017 were considered and will be reported elsewhere.

The Committee also agreed to the formation of a working group, led by Anne Morris, to examine and propose options for a fitting and lasting tribute to Miss Gillian Falconer.

The Committee meets on a fortnightly basis to critically and constructively review planning applications submitted to Fife Council for the St. Andrews Ward and those relating to the Conservation Area.

PLANNING AND DEVELOPMENT OBJECTIONS/COMMENTS, ETC.

The Planning Committee has commented on and objected to a variety of planning applications since the beginning of 2017; the most noteworthy being:

- Planning Application16/04015/FULL - Installation of replacement balustrade (retrospective) and Change of Use from public footpath to outside seating area at The Glass House, 80 North Street.
- Planning Application16/4149/FULL and 16/4150/LBC - Planning Application and

Listed Building Consent for internal and external alterations including single storey extension to rear, alterations to window and door, installation of window, alterations to wall to form gate and steps at 4 Louden's Close.

- Planning Application 16/04244/FULL - Erection of rear extension at the Albany Hotel, 56 - 58 North Street.
- 17/00292/FULL - Change of HMO from 4 to 6 persons at Flat 5, Hepburn Hall, 74 Hepburn Gardens.
- 17/00097/FULL – Part Change of Use of garden ground and erection of Nursery School storage shed at 44 South Street.

#### OTHER

- **12/01376/FULL – Refurbishment of the Student Association Building, St. Andrews Student Union at St. Mary's Place**

The Planning Committee made representation to Fife Council and to the University of St Andrews concerning the University's non-compliance with Planning Consent 12/01376/FULL – Refurbishment of the Student Association Building, St. Andrews Student Union at St. Mary's Place regarding the positioning and screening of mechanical plant and ductwork etc. on the elevations and roofs of the Union.

- **Redeveloped Gatty Marine Laboratory - Woodburn Place**

The Trust is in contact with the University of St Andrews on behalf of the Trust, the St Andrews Sailing Club and the Confederation of St Andrews Residents Associations concerning the suitability and adequacy of the parking proposals for the new Oceans Institute at East Sands.

- **Public Consultation Event for Potential Planning Application for the University of St Andrews' Proposed Music Centre on Land Adjacent to the Bute Building, Queens Terrace**

Members of the Planning Committee attended the public consultation at the Byre Theatre on Thursday, 25<sup>th</sup> January.

Contact has been made with JLL (the University's Planning Consultants) notifying them of the Planning Committee's support for the project as currently described. The subsequent planning application will be further reviewed and assessed when it is going through the planning process.

- **Public Consultation Event for Proposed Planning Application for St Andrews West**

The Planning Committee attended the public consultation at The Rufflets Hotel on Wednesday, 22<sup>nd</sup> February. The Trust will be giving St Andrews West significant attention over the coming months and years.

- **Public Consultation Event for Proposed Planning Application to Develop Student Accommodation on the gap sites at Agnes Blackadder Hall (ABH), North Haugh, and University Hall (UH), Kennedy Gardens.**

Members of the Planning Committee attended the public consultation at Agnes Blackadder Hall, North Haugh on Thursday, 2<sup>nd</sup> March. The planning application will be reviewed and assessed when it is going through the planning process.

### BOASE WOOD

The woodland is the remit of Ian Christie and I. In January the wheels were set in motion for a

tree re-inspection and arboricultural report to be carried out by Langton Tree Specialists. This took place on Wednesday February 8<sup>th</sup>. The timing of this survey could have not been better as I received a phone call on the 27<sup>th</sup> February from Mark Edward of Special Branch. I am delighted to report that following this communication and his email, our links with Special Branch are to continue. Following the advice in the survey report, Special Branch began important maintenance and remedial work in Boase Wood on Monday 6<sup>th</sup> March. He hopes to provide a team of two men for two days, every three months to work their way through the survey's requirements and suggestions. Mark has informed me that he intends to report back on a regular basis after each of their visits. This will keep our lines of communication open and transparent.

#### GORDON CHRISTIE PLAQUES BEQUEST

This sub-committee is the remit of Simon Kidd and David Watkinson. The two plaques receiving attention at present are for Adam Ferguson and John Hardie Wilson. They are also considering a request from Trust member, France Humphries. She would like to see a plaque erected in memory of the women who were condemned to death as witches. Another request recently received was submitted by Michael Buchanan. He referred to the Buchanan plaque that had existed at the entrance to the Buchanan building circa 1964. Unfortunately this had been "lost" when a disabled access was incorporated to the entrance. We hope to provide members with a progress report in the next newsletter.

#### GREGORY'S PILLAR

This is the remit of our Chairman, Bill Borthwick. A meeting with Eric Priest and St Andrews University is to be arranged to decide on the next steps.

#### BOGWARD DOOCOT

Dave Seeley as our Property Convener has been attending to this building. A new door has been fitted, making it safe and secure. Watson and Sons will start re-pointing work later this month, once there are no longer risks of a late frost.

#### SHOP FRONTS

The commercial premises in Church Street known as "The Continental Pantry" are at present up for let. As a result, I have been in contact with the agents. They are now fully aware of the Trust's concern over the future of the shop front's restored Victorian cast iron pillars. Shepherd's have been provided with the contact details for the Trust office, along with my own personal details. I have been assured that once the property is let, we will be informed. It is imperative that we use a proactive approach to establish a good rapport with the new owners. By doing so, we hope to safeguard these unique, ornate cast iron pillars for posterity.

## PRIDE OF PLACE AWARDS

These take place every four years, with the last event being held in 2013. A sub-committee was formed to plan our 2017 Awards. The members of this group are Anne Morris, Claire Tynte-Irvine, Simon Kidd, Derek Barrie and myself. At the time of writing, three meetings have taken place. The most recent was held on Tuesday 7<sup>th</sup> March. As this year is the Trust's 80<sup>th</sup> Anniversary, there are a number of events being held in celebration. Therefore it was decided that the Awards would take place at the AGM on the 11<sup>th</sup> May, following business and in place of a speaker. There will be two Awards categories which are as follows - "**Pride of Place**" Award and "**Old Stones, New Life**". This latter category, suggested by Trustee, Claire Tynte-Irvine has been introduced to highlight new amenities and initiatives in the town. The panel will select one winner from each category, with the option of recognising, if they choose, a third nomination from either category with a "**Special Mention**". The judging panel will be chaired by Dr Robert Steedman O.B.E and accompanied by Dr John Frew, Elizabeth Williams, along with Trust Chairman, Dr William Borthwick.

## MUSEUM GARDEN

As the New Year began, I was approached by Trustee, Anne Morris and asked if I would help in co-ordinating the work taking place in the museum garden. She was aware of my love of gardening and also my involvement with several gardening groups within the town. Andrew Johnson is the key player in the development of the sensory garden and the southern border restoration. However he very kindly said that along with his wife Liz, they would maintain the Scottish rose bed area developed by our dearly beloved benefactor, the late Gillian Falconer. They would also maintain the herb area and the D'Arcy Thompson garden. However the front garden, the back door area, herbaceous border and rockery required the attention of a small gardening squad. Along with my colleague, Felicity Chancellor, we have worked tirelessly, with enthusiasm and zest throughout February to improve and revitalise these remaining four areas of the museum garden. At present they are piloting a "Big Belly Bin", close to Sainsbury in Market Street. This new style of bin will help to reduce the numbers of unsightly refuse bins, cluttering the town centre. Our committee were more than willing to give "Clean and Green" our support, as was the Board of Trustees. In return, "Clean and Green" are willing to assist The St Andrews Preservation Trust with any future objectives.

## MUSEUM CURATOR'S REPORT

**For this and future newsletters the main museum report will be that of the curator to give members a clearer insight into the huge volume of work that goes on within the museum on a regular basis. The Convener of the Museum Committee will now report separately on the work of that committee.**

### ACCREDITATION

We were given our deadline for our Accreditation renewal earlier this year. Although this was initially for the end of June, the date has been put back to the beginning of October. This is mainly due to many museums in the sector struggling with the current three year renewal and the dates between applications are likely to be expanded further over the coming years. The application is currently going well and we are on track for having this completed on time. Trustees have approved our Collections Development, Environmental, Social Media and Volunteer Policies.

### DEVELOPMENTS IN THE MUSEUM SECTOR

Museums Galleries Scotland have recently announced changes to their funding in an effort to make the system easier for all. The two main grants are now the Small Project Fund (under £5000) and Museum Development Fund (between £5000 and £40000). Unfortunately, these changes also mean that less funding is available for some specific projects such as Festival of Museums now only being funded by 50%

Collections Trust are expected to update SPECTRUM standards in 2017, having been last updated in 2011. (SPECTRUM is the standard which museums follow for effective collections management procedures to ensure accredited status.) The date of this release, could affect our accreditation renewal however Museums Galleries Scotland are aware of this date and will work with any affected museum.

The Scottish government recently proposed to cut funding for the country's national collections by 4.5% for 2017-18. It's the second year in a row that the cultural collections budget has faced cuts, having fallen from a total of £85.9m in 2015-16 to 77m in 2017-18.

### EDUCATION

A small group of volunteers along with myself and our Administrator have been looking into

improving what the Museum offers in Education and Learning. Members of the group have been able to shadow school workshops in Perth which we hope will bring in new ideas.

## EXHIBITIONS 2017

We opened the year with our Research Group exhibition which was well attended with 244 visitors. Our Research group did another wonderful job on providing research on a variety of topic including- Professor Matthew Forster Heddle MD - Scotland's Greatest Mineralogist, Photographs by George Cowie and William Patrick - Professional and Amateur, Early Industries of St Andrews, The Mills of St Andrews.

Our StAnza exhibition was also well attended with a number of visitors coming to hear from the artist and poet for a talk on the closing day.

Preparations are also well underway for our Easter Exhibition 'Artists of St Andrews', which draws together 80 artworks from the Trust's collection in order to celebrate the 80<sup>th</sup> year of the Trust, as well as our Summer exhibition 'The Polish Connection, which explores the lives of those Poles who have formed a connection with the Town of St Andrews.

## GRANTS

We were successful in our grant application for Festival of Museums which means we can move forward in planning our event 'Our Victorian Childhood!'. We hope to bring in lots of families during the day and encourage visitors to come to the Museum over the summer.

## MUSEUM GUIDE

The Museum Guide has recently been updated to reflect the changes in our displays over the last few years. We are also in the process of translating these into different languages to ensure that we are able to reach out to an even wider audience.

## SHOP

I've made a few changes to the shop layout to try and make it easier for visitors to browse and I've included some more items from local makers. Myself and one of our volunteers are attending training to see if there's anything we can do to improve the shop further.

## STORES

I'm currently speaking to several storage companies regarding improvements within the store. Hopefully we can move forward with this soon to create a better environment for our collections.

## TRAINING

In addition to the retail training mentioned above, I have also attended a webinar on PR and hope to attend a training course over the next few months on Volunteer Management

## VOLUNTEERS

I've contacted a number of our volunteers recently to update their emergency contact forms – and I'd like to say thank you to all who sent these back. I now hope to update these on a rolling basis every three years. The Museum always needs new volunteers and I'd like to ask if any of our members are interested in volunteering, or would like more information, please do get in touch.

## FURTHER INFORMATION

I hoped to achieve a number of objectives this year which have already been shared with Trustees and Committee Members. These include ensuring Accreditation for the Museum; developing a more suitable storage environment for our collections; continue to deliver exhibitions and events; increase our participation on social media; develop the Museums retail offering; attend volunteer management training; create better environmental conditions in the Museum; improve the information we hold on Adlib and; develop our educational offerings.
